1. **Adoption of the Agenda** Cindy Candler moved that the Board of Education adopt the agenda of the reorganization meeting, as presented. Pat Bryant seconded the motion. The motion carried: 7-0.
2. **Approval of Minutes** Keith Gillming moved that the Board of Education approve, as presented, the minutes of the regular and closed sessions of March 11, 2008, and the special open and special closed sessions of March 24, 2008. Robert Dillon seconded the motion. The motion carried: 7-0.
3. **Missouri State Law, Section §115.124** Ralph Stahlhut moved that the Board of Education ***appoint, as presented, the candidates who filed for "Director, Board of Education" into said office***; where under Section RSMo.115.124, the number of candidates who filed for said office was equal to the number of positions to be filled; and in which all conditions were met and no election was held. Keith Gillming seconded the motion. The motion carried: 7-0.
4. **Oath of Office** Ruth A. Petrov, Vice-President of the Pattonville Board of Education, administered the oath of office to newly elected board members, **Ronald C. Kuschel, Cynthia R. Candler** and **Patricia Polster**. Ronald Kuschel, Cynthia Candler and Patricia Polster affirmed the oath.

Before continuing the reorganization meeting, Keith A. Gillming stepped up to say a few words upon departing his office. Keith touched on the strengths of every single board member and administrator present, as well as some of those not present. Keith thanked everyone, including previous board members and superintendents for their hard work in making Pattonville the great school district that it is today. Keith also shared that he was sure, the current superintendent, Dr. Michael A. Fulton, would go on to be one of the best superintendent's Pattonville has ever had.

**5. Election of President**

**6. Election of Vice-President**

Pat Bryant nominated Cindy Candler for the position of vice-president of the board. Ralph Stahlhut moved that nominations be closed and Cindy Candler be elected vice-president by acclamation. Robert Dillon seconded the motion. The motion carried: 7-0.

**7. Appointment of Board Member to Pattonville Education Foundation Board of Trustees**

Robert Dillon nominated Pat Bryant for the position of Board member on the Pattonville Education Foundation Board of Trustees. Cindy Candler moved that nominations be closed and Pat Bryant be elected by acclamation. Ralph Stahlhut seconded the motion. The motion carried: 7-0.

**8. Appointment of Board Member as MSBA (Missouri School Boards Association) Delegate**

Cindy Candler nominated Robert Dillon for the position of Pattonville School District delegate to the Missouri School Boards Association. Pat Bryant moved that nominations be closed and Robert Dillon be elected by acclamation. Ron Kuschel seconded the motion. The motion carried: 7-0.

**9. Appointment of Board Member as MSBA Alternate**

Ralph Stahlhut nominated Cindy Candler for the position of Pattonville School District alternate to the Missouri School Boards Association. Ron Kuschel moved that nominations be closed and Cindy Candler be elected by acclamation.

Robert Dillon seconded the motion. The motion carried: 7-0.

**10. Appointment of Board Member to Represent Pattonville on the Governing Council of Special School District**

Robert Dillon nominated Ron Kuschel for the position of Pattonville School District Board representative to the Special School District Governing Council. Pat Bryant moved that nominations be closed and Ron Kuschel be elected by acclamation. Cindy Candler seconded the motion. The motion carried: 7-0.

**11. Appointment of Board Member as Pattonville Alternate Representative on the Governing Council of SSD**

Ron Kuschel nominated Patty Polster for the position of Pattonville School District Board alternate to the Special School District Governing Council. Cindy Candler moved that nominations be closed and Patty Polster be elected by acclamation. Robert Dillon seconded the motion. The motion carried: 7-0.
